



PUBLICATION AGREEMENT FOR "Y DDRAIG GOCH: AN INTERDISCIPLINARY HONORS JOURNAL"

This Publication Agreement ("Agreement") is entered into between the contributor ("Contributor") and *"Y Ddraig Goch: An Interdisciplinary Honors Journal"* ("Journal"), published by the Lloyd International Honors College at the University of North Carolina at Greensboro ("UNCG"), to govern the submission, review, and publication of the Contributor's manuscript ("Manuscript") in the Journal. The Journal requires the execution of this Agreement to proceed with the review and publication process; publication of the Manuscript cannot proceed without the Contributor's acceptance of the terms herein. By submitting the Manuscript to the Journal, the Contributor agrees to be bound by the following terms and conditions:

1. Definitions

- **"Journal"** refers to *"Y Ddraig Goch: An Interdisciplinary Honors Journal,"* including its editorial board, staff, and publisher, the Lloyd International Honors College at UNCG.
- **"Contributor"** refers to the individual(s) submitting the Manuscript, including all co-authors, if applicable.
- **"Manuscript"** refers to the submitted work, which may include case studies/case reports, research notes/short communications, research articles, or review articles, encompassing all text, figures, tables, and supplementary materials provided by the Contributor.
- **"Publication"** refers to the act of making the Manuscript publicly available through the Journal in any format, including print, electronic, or other media.

2. Submission and Exclusivity

2.1. Originality and Non-Simultaneous Submission

The Contributor affirms that the Manuscript, whether a case study/case report, research note/short communication, research article, or review article, is an original contribution authored by the Contributor, has not been previously published in whole or in part, and is not currently under consideration by any other journal, publisher, or entity at the time of submission to the Journal. The Contributor agrees not to submit the Manuscript to any other journal, publisher, or entity while it remains under review by the Journal.

2.2. Exclusivity During Review

Throughout the review process, from submission until a final decision (acceptance, rejection, or withdrawal) is communicated by the Journal, the Contributor shall maintain exclusivity with the Journal and refrain from submitting the Manuscript elsewhere.

2.3. Exclusivity After Acceptance

Upon acceptance of the Manuscript for publication, the Contributor agrees that the Journal shall have the exclusive right to first publication. The Contributor further agrees not to submit, publish, or distribute the Manuscript, in whole or in part, through any other journal, publisher, or platform following acceptance, unless prior written permission is obtained from the Journal's editor.

2.4. Pre-Publication Sharing on Academic Repositories

The Contributor agrees not to deposit or share the Manuscript, in whole or in part, on academic repositories such as arXiv, ResearchGate, or institutional repositories prior to publication by the Journal, as this would violate the Journal's exclusive right to first publication. If the Contributor wishes to share a preprint or pre-publication version of the Manuscript on such platforms, they must obtain prior written permission from the Journal's editor by contacting amirrezahmi2002@gmail.com. Unauthorized pre-publication sharing may result in the rejection of the Manuscript or termination of this Agreement at the discretion of the Journal.

3. Withdrawal

3.1. Withdrawal Before Acceptance

The Contributor retains the right to withdraw the Manuscript from consideration at any time prior to its acceptance for publication. To exercise this right, the Contributor must submit a written notice to the Journal's editor via email at amirrezahmi2002@gmail.com. Upon receipt and acknowledgment of the withdrawal notice, this Agreement shall terminate, and neither party shall have further obligations to the other.

3.2. Withdrawal After Acceptance

After the Manuscript has been accepted for publication, withdrawal is permitted only under exceptional circumstances, such as the discovery of significant factual errors, ethical violations, or other unforeseen issues that compromise the integrity of the work. The Contributor must submit a detailed written request to the Journal's editor, explaining the circumstances. The editor reserves the right to approve or deny the request at their discretion. If withdrawal is approved post-acceptance, this Agreement shall terminate, and neither party shall have further obligations to the other.

4. Rights and Permissions

4.1. Grant of License

The Contributor grants the Journal a non-exclusive, perpetual, irrevocable, and worldwide license to publish, reproduce, distribute, display, and archive the Manuscript in all formats and media, including but not limited to print, electronic platforms, the Journal's website, and academic databases. This license also permits the Journal to translate the Manuscript and create derivative works as necessary for publication.

4.2. Open Access Commitment

As an open-access publication, the Journal makes all content freely available to the public. The Contributor agrees that the Manuscript, upon publication, will be distributed under a Creative Commons Attribution-NonCommercial 4.0 International License (CC BY-NC 4.0), allowing non-commercial use, sharing, and adaptation of the work with proper attribution to the Contributor and acknowledgment of the Journal as the original publisher.

4.3. Copyright Retention

The Contributor retains full copyright ownership of the Manuscript. However, by entering into this Agreement, the Contributor grants the Journal the rights outlined herein. The Contributor may reuse or republish the Manuscript in future works, provided the Journal is cited as the place of first publication.

4.4. Sharing on Academic Repositories

The Contributor is permitted to deposit the published version of the Manuscript, or the accepted manuscript, in academic repositories such as arXiv, ResearchGate, or institutional repositories after publication in the Journal, provided that the Journal is cited as the place of first publication in accordance with Section 4.3. Such sharing must comply with the non-commercial use requirements of the Creative Commons Attribution-NonCommercial 4.0 International License (CC BY-NC 4.0) as outlined in Section 4.2.

5. Representations and Warranties

The Contributor represents and warrants that:

- The Manuscript, whether a case study/case report, research note/short communication, research article, or review article, is an original contribution authored by the Contributor and does not infringe upon the intellectual property rights, privacy rights, or other legal rights of any third party.
- The Manuscript has not been previously published, nor is it currently under review elsewhere, as specified in Section 2.
- All third-party materials (e.g., images, quotations, or data) included in the Manuscript have been properly licensed or authorized for use, with documentation available upon request.
- The Manuscript adheres to all applicable ethical standards, including those related to research conduct, authorship attribution, and data integrity.

6. Indemnification

The Contributor agrees to indemnify, defend, and hold harmless the Journal, its editors, the Lloyd International Honors College, UNCG, and their affiliates from any claims, losses, damages, or liabilities (including legal fees) arising from the submission or publication of the Manuscript, including but not limited to allegations of plagiarism, copyright infringement, or ethical misconduct.

7. Governing Law and Dispute Resolution

This Agreement shall be governed by and interpreted in accordance with the laws of the State of North Carolina, excluding its conflict of law provisions. Any disputes arising from this Agreement shall be subject to the exclusive jurisdiction of the state or federal courts located in North Carolina.

8. Entire Agreement

This Agreement represents the complete understanding between the Contributor and the Journal concerning the Manuscript. It supersedes all prior agreements, negotiations, or understandings, whether written or oral. Any modifications to this Agreement must be made in writing and signed by both the Contributor and an authorized representative of the Journal.
